Ocala resident Seath Jackson, 15, was reported missing on April 18, 2011, by very concerned parents, with good cause. The day before, he was lured to a house by an ex-girlfriend, hit in the head and shot, but he still tried desperately to flee the home in Summerfield. It would be a few days later the details would start to come out about what had happened to Seath Jackson. Michael Bargo, 18; Amber Wright, 15; her brother Kyle Hooper, 16; Charlie Ely, 18; and Justin Soto, 20, were charged with first-degree murder. James Haven, 37, a stepfather was charged with accessory to murder for allegedly helping to dispose of the body and driving Bargo out of town.

Assistant State Attorney Robin Arnold, one of the prosecutors on this complicated and disturbing case, reviews the evidence, motives, and the legal procedure involved in dealing with juvenile murder defendants.
