### 1ST QUARTER MEMBERSHIP MEETING - JULY 18, 2009

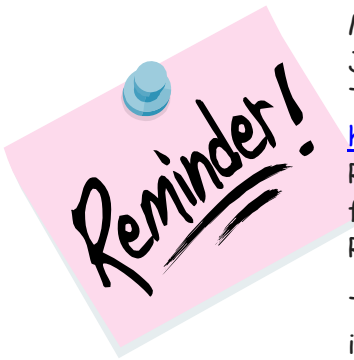

Ten (10) days prior to the meeting (**on July 7, 2009**), each officer, committee chair, and chapter liaison is to submit a report attached to an email (in .rtf, Word, or WordPerfect format) to the Website Chair ([sbatchel@tampabay.rr.com](mailto:sbatchel@tampabay.rr.com)). A "Report FLASH" will be distributed to all members seven (7) days prior to the meeting with the link to the reports on [www.falss.org](http://www.falss.org). The reports may be presented orally at the meeting. Please bring the original of your report for the Secretary.

Those reports necessary for distribution to members – registration forms for futures meetings, etc., PLUS the report of any officer, chair, or chapter liaison who missed the deadline for emailing the report to the Website

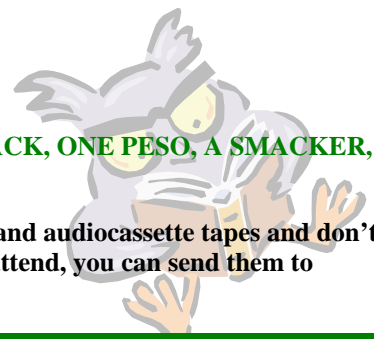
